"US-India Military Nexus and Implications for Pakistan's Security"

Abstract

This article focuses on the evolving India-US military nexus and its impact on Pakistan's security. Using theoretical frameworks of realism, it explains how this partnership has bolstered India's military capabilities, posed significant security threats to Pakistan, and enhanced India's capability for proxy warfare. These developments have created a precarious security environment for Pakistan, contributing to a regional security dilemma and supporting India's emergence as a regional hegemon. The analysis highlights the role of advanced defense agreements, technology transfers, and joint military exercises in shifting the regional power balance. It also underscores the challenges Pakistan faces, including threats to its nuclear deterrence, increased proxy warfare, and its longstanding stance on Kashmir since independence. The study emphasizes the need for Pakistan to adopt a proactive approach, strengthen alliances, and implement counterbalancing strategies to address these emerging threats effectively. Recently, India has also taken initiatives to further strengthen its proxy warfare capabilities. As a result, Pakistan faces multifaceted challenges from this nexus, including border tensions, nuclear deterrence concerns, U.S. alignment with India, and a growing power imbalance. This article primarily focuses on these issues and explores strategies for Pakistan to effectively counter them.

Introduction

The diplomatic relationship between the USA and India started soon after the Indian independence in 1947. At that time the USA was searching an ally in south Asia to fulfill its aims and to check communism. In Cold War, India decided to practice policy of neutrality in accordance with the direction of the Prime Minister Nehru. The USA was not comfortable at this non-alignment programmer; however, the US did not sever its relations with India. On the other hand, Pakistan was search for a strategic partner which could fulfill its economic and military needs because of security threats from India. Consequently, because of its favorable geographical location and a newly born rival, India, Pakistan actively strove to seek an alliance with the US. The USA was very friendly with Pakistan and so both the countries passed through strong bi-lateral relations. During cold war, Pakistan presumably enjoyed this relationship in the form of economic and military aid; two major military cooperation pacts were SEATO & CENTO. At some point, however, the USA also instrumentalised Pakistan for its purposes several times. In the Soviet-Afghan War Pakistan helped the defeat of the Soviet Union, which was advantageous for the USA. However, non-aligned country such as India also had nice terms with USSR as both parties signed the 1971 Treaty of Peace, Cooperation, and Friendship. This we can conclude as that during the cold war, the USA had a pro-Pakistan bias in their foreign policy.

The end of Cold War resulted in dramatic changes of political map of the world in the post-Cold War period. The USA and India rethought their foreign policies. A range of US foreign policy commentators proposed India as a future ally due to India's growing economy and its ability to act as a counterbalance to China, maybe militarily. While the western scholars looked towards the next terror threats emerging from a rising China and its traditional rival Pakistan, but Indian foreign policy analysts did the same. They thought that they would not be able to cope with the two threats at the same time. The shift in the US foreign policy after the cold war and 9/11 was towards India but not very visible. Both cultivated a sound strategic partnership in terms of education, economy, and technology upgrading as well as military mutually beneficial cooperation. Because of the nuclear test conducted in May 1998 in Pakistan the country faced sanctions and many ceilings were cut on aids to US. In essence, new sanctions to Pakistan came with more coup that Musharraf accomplished in 1999. The potential reasons for the good interaction between the US and India were numerous. However, there were increased collaboration between the two nations the US and India over the numerous challenges to make advancements in trade, defense, and security especially in counterterrorism and checking China. This developing relationship has changed the strategic matrix of South Asian region and brought new dynamics in Pakistan, India and United States relation.

The partnership between the U.S. and India is followed by a large number of common concerns. The various American interest in India however countervails to the major concern, the need to checkmate the Chinese influence in the Indian sub-continent. With reference to neo-realism some U.S. experts even view India as regional 'Policeman' assisting the U.S. in countering threats posed by China. A major reason that strengthens U.S. interest in India again is the size of population and its prospects for investment. As famously said, America and India the world largest democracies are better together as a force for good in the world. It creates a very strong bond between the two. India also has appendixes in the U.S. because it lacks capability to address the strategic threat of china and Pakistan individually. America remains one of India's most critical strategic partners offering market access arrangements and better political-security coordination. However, this enhancing relationship is posing a threat to Pakistan and China and evidently, this increase the intensity of rivalry in South Asia region and leading to an Arms Race. This fundamental has altered

the power relations in the region, as the rationale of India's quest for power projection capability to meet the so-called threat has translated to a greater allocation of resources to defense thus signaling an arms race within the region.

Pakistan feels threatened by the military cooperation between the US and India and regards the growth as a dominance in the South Asian region. India is now recognized as a hegemon in South Asian region. Due to the wars and conflict history between Pakistan and India especially over the KASHMIR issue this nexus is considered a security threat. As we all know, India has been enhancing it strength, both in terms of its economy and its defenses. Pakistan perceives this as a security issue because India is getting more and more influential in Baluchistan and Afghanistan. This may unbalance security situation in Pakistan and lead to next problems, on the other hand India is capable to conduct proxy warfare that indirectly poses threat to Pakistan security.

Therefore, the main focus of my study is devoted to revealing the increased security threats for Pakistan as a result of India-US cooperation. They are both in the process of modernization of dyna high tech military arsenal and carrying out personnel exchange military exercises. They have sealed many military deals, which I'll discuss in the discussion section, as mentioned above. Moreover, when India has grown into a powerful military not only in South Asia but in the whole world it has introduced itself in various plots and proxy warfare against its replica, Pakistan. We shall expand on this under the next discussion section. Pakistan is now realizing growing Indian military capabilities in all aspects- in weapon, increase in stockpile and purchasing of sophisticated arms, military strategies and proxy warfare tactics. This poses a considerable problem and a security risk for Pakistan to deal with. Therefore, the role alternative should be sought to support security and balance of power in South Asian region; otherwise we are doomed to lose our dignity and balance of power. What roles does the strategic Military Nexus between the US and India play in the security of Pakistan? What measures that Pakistan can take have been discussed under each implication.

- How does the US-India strategic Military Nexus impact Pakistan's security?
- What strategies can Pakistan adopt to mitigate and respond to these implications?

Theoretical Framework

The US-India military deal and its impact on the security of Pakistan can be viewed under the light of realism, a theory according to which states are the main actor and act without reference to any other reason, excepting self-interest in a world which is anarchic. From a realist point of view both the United States and India seek power and work to achieve their nation's goals and interests. Importantly for this analysis, which is located within the neo-realist framework advanced by Kenneth Waltz, I will pinpoint the shift in the power relationship between India and Pakistan and its consequences in the security complex. The existing power relationship between India and Pakistan as well as the closeness of the US-India military ties raise insecurity in South Asian region. This problem emerges for the reason that India's attempts to reach for a greater security through the improvement of defense relations with the United States as well as militarization and modernization can be regarded by Pakistan as a threat which leads to increase its military potential. Kenneth Waltz's neo-realism dispels the nature of man and pays a lot of attention to the architecture of the international system. US-India military relations Many scholars have considered the military relations of the United States and India as a response to the bipolar world

of cold war to unipolar and then to the multipolar world. The strategy of forming partnership with India is to counterbalance of China as a world super power. For Pakistan, such a situation is contradictory and creates the security dilemma, making seek counterbalances, for instance deepening of pacts and cooperation with China and development of the nuclear potential.

We will also undertake an analysis with the help of Mearsheimer's Offensive Realism where by a country increases its military strength, specifically in this case support by the US, increase the chances that India will turn to offense. India's activities in this regard – its aggressive statements (From 'yeh Ghar mein ghus kar maarenge'), reveals aggression towards Pakistan. This can in fact escalate tension and make feel Pakistan directly threatened and therefore develop this offense. Offensive realism by John Mearsheimer assumptive of states seeking for dominion in their respective regions due to insecurity that exists in the system of anarchy. It is possible to regard India's increasing military potential and a cooperation with America as a bid to gain supremacy in South Asia. Such hostile preparations enhance insecurity in Pakistan, making it to develop measures including improving its defenses and form alliances. However, there is defensive realism defended by Robert Jervis and others that postulates that states do not overextend, so that others do not unite against them. Some of the action taken by Pakistan include; developing small scale nuclear weapons, improvement of the country's defense architecture is best understood within the defensive realist prism of coping with likely aggressive adversaries' intentions.

On a separate note, the weaker power, Pakistan's reaction will be examined through the prisms of defensive realism whereby Gilpin claims that the phenomenon functions. Under this context, Pakistan wants to build up its defenses in view of the threats from India. Given the scenario a number of initiatives from the Pakistani side including enhancement of nuclear capability and concentrated defensive approach are the efforts to avert aggression and safeguard from Indian aggressive posture. Also, post classical realism (as assumed by Robert Brooks) will explain how states are rational in international relations with respect to threats posed to them by other states. Pakistan may, therefore, take preemptive actions not only on military, but also on rational grounds depending on the current unraveling security scenario in the light of the sharpened military relations between the United States and India. Post-colonialism therefore offers the theoretical framework through which we can understand the nature of inheritances and power structures impacting on today's' IR. While American engagement with India is based on common Interest and democratic Indian polity, that of Pakistan is relatively recent and born of colonial or rather neo colonial background as Pakistan is struggling to find strategic space in the world power dynamics. This framework helps to explain, how historical narratives influence security perceptions of Pakistan.

In summary, this study will analyze the US-India military nexus and its implications for Pakistan's security through the following theoretical lenses: Classical Realism by E.H. Carr, neo-Rea listItemlisim by Kenneth Waltz, Offensive Realism by John Mearsheimer, Defensive Realism by Robert Gilpin as well as Security Dilemma and Post-Classical Realism by Robert Brooks. This use of multiple theories will help in giving an all-round perspective of how the increasing military ties between the USA and India are likely to impact on Pakistan's security and strategic posture.

Discussion

Historical Behind the Military between the United States and India

This paper focuses on the changes in military relations between the US and India over the decades to capture the face of the emerging power dynamics, political development in both nations and mutual interests in the contemporary international relations system. It is here important to

understand the temporal dynamics of this relationship and the milestone events that have grounded its progress. The early Cold War period of the postcolonial Indian state, beginning soon after the transfer of power in 1947, saw the US-India relationship more in terms of divergence than similarity. India was led by the Prime Minister, Jawaharlal Nehru who chose a policy of neutrality, in order to avoid being associated with the Cold War between the two super powers with United States and the Soviet Union. The US needed to safeguard the region to prevent communism from growing there while on the other hand the US aimed at intensifying its partnership with countries in South Asia. What Pakistan can do is transfer this shift towards diversification of its alignments where it aims to cement relations with other great powers including China, Russia Turkey and the leading Gulf states. In addition, it will be able to focus on economic stability and internal development thus not over stretching its military power in solving international politics.

The worsening of military cooperation with the USA increases the political potential of India in South Asia, making it have a strategic advantage in a confrontation with Pakistan.

US Interests in Realist Terms: To USA, it is beneficial to side with India as it makes a check on China both internationally and in particular, in the region of the Indo-Pacific. The US has acknowledged India as a second-tier power, which it can enlist into countering China's influence in Asia. When it comes to Pakistan, realism provides an answer as to why this state chooses China as a counterbalance. This escalating US-India relationship raises Pakistan's security threat perception and makes it under any circumstances expand cooperation with China and enhance its second-tier nuclear capability. Nonetheless, the triangular strategic relations between the US, India and Pakistan pose a threat to the exercising peace in South Asia as they have created a nuclear race and have developed high level of mistrust.

Liberalism qualifies the influence of international institutions such as the United Nations, economic entanglements thus cooperation in setting the behavior of the states. The US-India military nexus can be analyzed through this lens:

For example, the management of participation in elements like the China Pakistan Economic Corridor can be seen to be noble to the instincts of economic globalization and interdependence promoted by liberals. Still, the low level of Pakistan's engagement with international trade systems and organizations is problematic within this framework.

Liberalism also presupposes that the growth of regional interdependence may decrease conflicts. However, it appears from the current trends that increased bilateral cooperation will only augment current dominant alignment (US India and Pakistan China) and Mold regional integration.

Constructivism focuses on the part played by ideas – identity, norms and perception within the behavioural matrix of nations. The US-India military ties can best be explained by the endowment of democratic polity, and perceived threat posed by China.

Shared Identity of Democracies: The US and India highlight the role of democracy in both countries, and base their relationship on the fact of two democratic nations. This common essentialization enhances the military relations between them, and provides a normative legitimacy to their partnership.

Pakistan's Position in Constructivist Terms: Pakistan's relationship with the US was traditionally based on a counterterrorism approach with the background of Cold War. However, as the geopolitical narrative has changed in favour of a containment of China, Pakistan's support of China confirms its role as an opponent in the US-India strategic paradigm. This perception pushes Pakistan to increase its own strategic partnerships which especially goes with China. Prisoner's Dilemma in Regional Relations: This conflict represents a perfect prisoner's dilemma that exists between India and Pakistan; despite a better future for both states without the high levels of military confrontation, the two cannot trust each other to make the first move. The US-India relationship deepens this conundrum by according to Pakistani strategic vulnerability, specifically the idea of being surrounded. According to the theoretical model called realism it is possible to explain this military relation between USA and India because states are self-interested and tend to maximize their power. Among these theories in particular neo-realism offers the explanation to the structural arrangement of threatened power that gives rise to the causation for security entmanager challenges such as Pakistan.

Offensive realism according to John Mearsheimer therefore presupposed that states are after power as much as possible with a view to security. In this regard it can be well understood that India wants to build up a strong military and strong relation with US to pressurize Pakistan and dominate in South Asian region in general. Reaction of Pakistan to the Clinton's doctrine Pakistan worked to enhance the nuclear capability and normalized the relations with China confirms the defensive realism doctrine which a theory supports acquisition of power solely for the defense.
