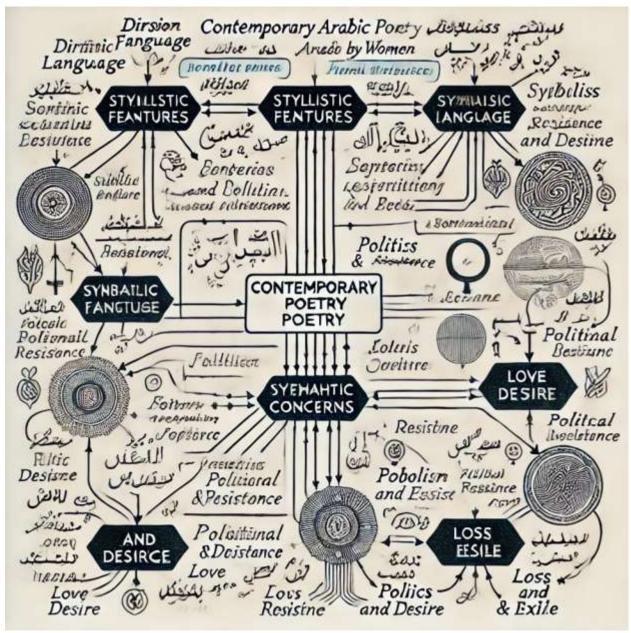


Figure 1: authors flowchart showing the stylistic and thematic analysis of contemporary Arabic poetry written by women

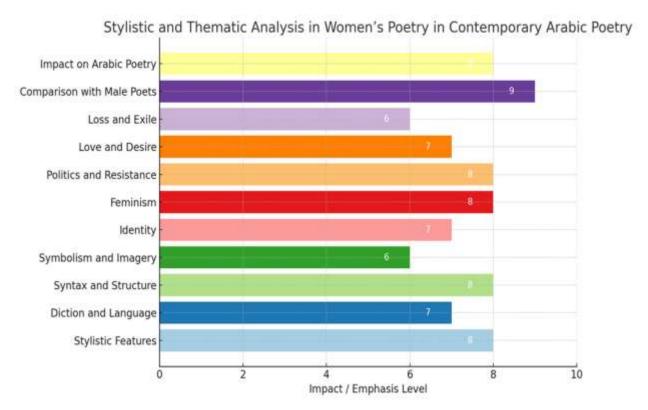


Figure 2: bar chart representing the stylistic and thematic analysis in contemporary Arabic poetry by women. It highlights key aspects such as diction, syntax, symbolism, and thematic concerns, with a focus on their impact and emphasis.
